## From the President:

### Attached Garages and Indoor Air Quality



I see a lot of attached garages in the course of my inspection week. Although many inspectors look for problems with the fire wall for fire safety reasons, not all inspectors realize the implications of how the contents of their garage are contributing to the overall indoor air quality in the home.

I am fully aware that evaluation of indoor air quality is not required under the state's standards of practice for home inspectors. But one way to view our profession is as consumer safety advocates, and I believe this topic is worth further discussion.

First, how do we even know this is a problem? A research group at the University of Michigan performed a study on the migration of volatile organic compounds (VOCs) from attached garages in 15 single-family homes. A total of 39 VOCs were detected indoors, 36 VOCs were detected in the garage, and 20 VOCs were detected in ambient air. Air flows and source partitioning (garage vs. indoor) were studied using tracer gases. Ratios of volatiles detected in the garage and in the home showed that nearly all of the benzene and most of the fuel-related aromatics detected in the homes resulted from migration from garage sources.

The sources of VOCs are simple – it's the junk we all store in our garages, including gas-powered outdoor power equipment such as lawnmowers, snow blowers, and weed whackers, and their fuel and oil. Other common sources are automotive supplies, lawn and garden chemicals, paints, solvents, adhesives, and other household chemicals.

The simplest and most effective way to improve indoor air quality and health for the home's current or future owners is to keep the garage air as "clean" as possible. Keep all that smelly stuff in an outdoor shed, and not in the garage. This is especially helpful in the summer months, where warmer temperatures result in higher solvent vapor pressures, which elevates the levels of VOCs in the garage. Paint and other chemicals should always be kept in airtight containers, wherever they are stored.

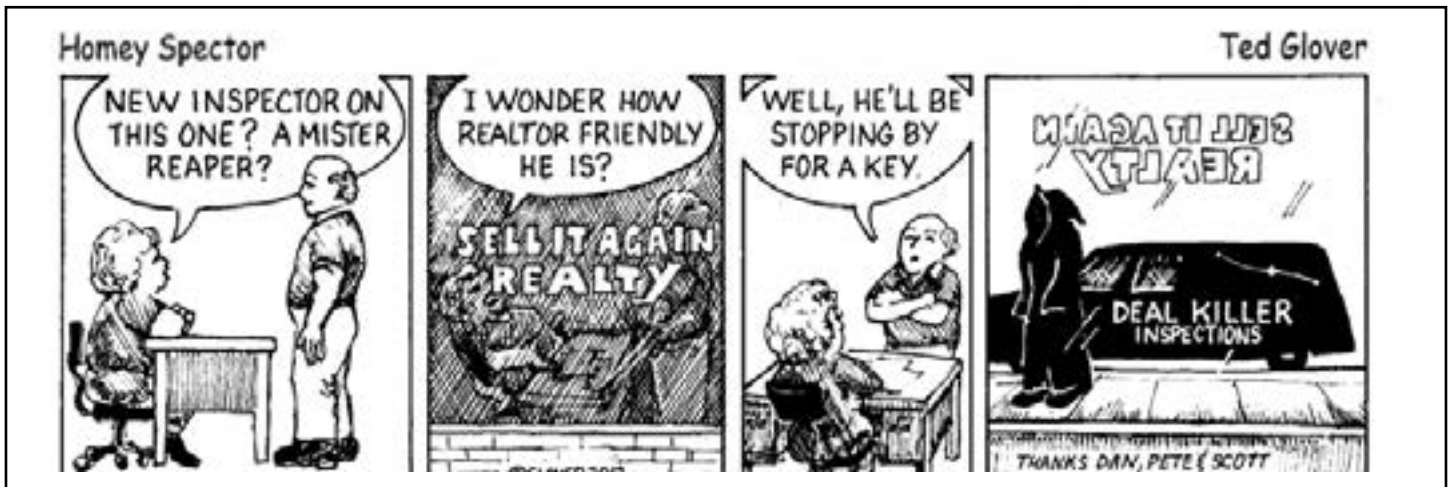

Building a shed is not always a practical solution, however. Homeowners can minimize, but not eliminate, the migration of VOCs from the garage by ensuring that the garage firewall is intact, including good seals at the entry door to the house, and most importantly, keep that entry door closed as much as possible. An automatic door closer can help with this as well. A path of continuous improvement in air quality will lead to cleaner, healthier air for the home occupants.

I believe it is the job of every home inspector to arm our clients as much information as possible to help them live a safe and healthy life. When I see a garage filled with common indoor air pollutants, I tell my clients to remove those pollutants and consider adding an outdoor storage shed to improve the IAQ of their home. As WAHI members, let's be leaders in our profession and go above and beyond for our clients.

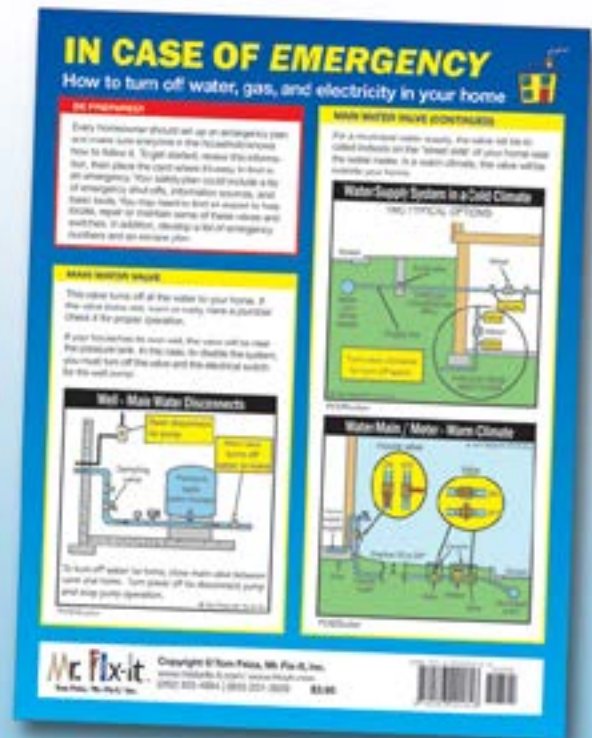
