From the President:

What is a "Defect" as a Home Inspector?

Happy Halloween everyone!

I was having a discussion with one of our members last night. He called about an issue with a buyer and the perception of different thoughts from the parties involved in the sale of a house on what a "defect" is on a house inspection. The buyer was told by the selling Real Estate Broker that the inspection has to state that an item in the report is a "defect" in order to ask for repair or get out of the deal. This is actually a complex issue to define on two basic fronts. Since my wife is a Real Estate Broker, and has been in real estate for 25 years, we talked about the subject after my phone call. My wife also basically retired from my company a few years back. She used to be my office manager when we had 7 inspectors covering three WAHI Chapter areas. I felt she would have great feedback and some advice looking from both the realtor side and the inspector side.

In this case for the inspector on this home sale, the buyer was also a realtor. The buyer said that he needed the word "defect" in the report to get out of the home sale since they no longer wanted the house due to the conditions of the house. This was what the listing broker told them.

So the two points of importance are as follows-

1 - There is no definition of a "defect" in our licensing, and our requirements are "to observe and describe." We are not required to rate a component. Also, observe and describe is a wide open interpretation. I can observe and describe windows as "double hung, wood, basement, fixed, functional, poor," and/or many other words to choose from. Also, one of the great advantages we have is we can design our reports in many, many different ways. While our job definition has many "Must Report" items, we also have a lot of freedom as to how we report.

2 - Our licensing has no reference to a real estate transaction or sale. We are not in direct involvement with a real estate sale, we did not sign into any real estate paperwork. While we are most of the time performing an inspection because of a real estate sale, we are not directly involved in that contract.

President's Letter (cont'd)

As my realtor wife heard the conversation from me, she stated that really, the realtors involved here are not performing their duties properly. This inspector stated that he rated the issues as Repair/Review, and explained the issue while directing that further review should be performed by a qualified contractor. This is the important fact and what is necessary for you to have in your report. We are not the expert, we are the family doctor. We referred the issue to the Oncologist because they are the expert. Due to the inspectors report language, the buyer can get a professional opinion and still probably walk away if needed. I think the important point is really not the rating, but the verbiage in the comment. BUT, where potential liability and problems would come up, is if we rated the issue on the component as "Satisfactory" or "Functional." So in summary, it is important that we describe and advise properly, and that the rating, if you are using a rating system, directly follows the comment and that they all work properly together.

This job gets more difficult every day, and not reporting properly opens you to a lot of liability. We hear stories now of sellers filing complaints or lawsuits against inspectors. A complaint to the state is not something you can do anything about, but a lawsuit is different. This would be a great topic for a "Roundtable" discussion in your chapters. There are always many different points of view that we can all learn from each other. In this case, the inspector did his job properly and the other parties involved need to do theirs.

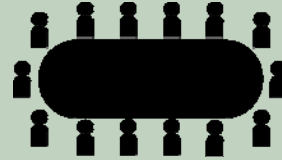

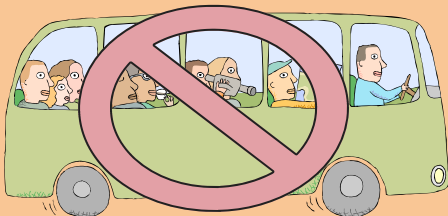
